

# FOUR WINDS CELTIC Music Festival

1 Weekend ~ September 19 & 20, 2009

## Vendor Application/Contract

Saturday, 12:00 am – 10:00 pm and Sunday 2:00 pm till 7:00pm.

**Contract Deadline & Fees:** This document serves as both application and contract. Please fill out and return it with applicable fees promptly so that we may process your application. In order to provide vendor space this contract must be accompanied by a **\$30 vendor fee**, check or money order, by September 1, 2009.

Once accepted, a faire-signed copy of your vendor contract will be returned to you. **All checks must be made out to Dustin Stephens.**

**Hours:** All shops must open promptly each contract day (contracted dates are September 19 & 20, 2009) **at 12:00 am and will close no earlier than 8:00 pm**, unless otherwise instructed by the Faire office. There are to be no vehicles on the Faire site from 11:00 pm until 10:30 p.m.

**Rules:** All vendors must abide by the rules and policies of Four Winds Faire. The rules and policies are incorporated herein and become part of this contract between vendor and Faire. This contract is terminable at will by Four Winds Faire.

- ❖ We ask that you keep alcoholic beverages discreetly confined to your vendor area and to drink responsibly. **Openly drunken behavior or serving alcohol to minors will not be tolerated.** Do not smoke in front of the patrons unless in period pipes.
- ❖ There is a "no noise" rule beginning at **11:00 pm and ending at 7:00 am**. This applies to the Faire site and to the campground area out of respect for the vendors and performers who must work the following day, and for our neighbors. There will be no unauthorized after-hours parties without express consent from Dustin & Kristin Stephens (Owners/Directors).
- ❖ The site will be closed to all traffic from 11:00 am to 10:30 pm. **ALL vehicles must be off the site by 11:00 am.** Vendor parking is provided in the main parking area. Absolutely no parking on the side of the road.
- ❖ There will be **no illegal substances** brought onto the Faire site, the campgrounds, or on any part of the properties managed by Four Winds Faire. Any person or persons caught with any illegal substances, or distributing these items, will be removed from the Faire site immediately and legal action will be taken.
- ❖ If you have a problem with any of our staff or with anyone identified as part of the Faire, please report any incidences to Keith Waddoups (General Manager), Greg Grindstaff (Vendor Liaison), or Dustin Stephens & Kristin Stephens (Owners). They will deal with the complaint promptly.
- ❖ The carrying of guns on the faire site is prohibited. Period firearms and other such weapons are only allowed with permission from Four Winds management.
- ❖ Vendors are responsible for collection and disposal of all their garbage. At the end of each faire day, vendors must police their area for trash, cigarette butts, etc. All household garbage must be put in plastic bags, then tied at the top and put in the large black trash receptacle provided by the Faire. Do not put bags of garbage or large items into trash cans set out for patron use.

**Structures:** All structures, whether temporary or permanent, will be approved by the Faire and will fit the Renaissance theme of the Faire. If interested in leasing an existing structure, contact us for a lease contract. For custom booth construction, contact Dustin Stephens regarding construction, building specifications and a lease contract. All custom-built structures and vendor spaces must be maintained to faire standards and kept in good repair (refer to lease contract).

**Special Provisions:** The undersigned agrees to indemnify Four Winds Productions, the Four Winds Faire, the Vizcaya Ranch, and their owners, managers, and staff; and hold aforementioned parties harmless from any liability whatsoever from any claim to injury including, but not limited to, bodily injury, property damage, fire, theft, explosion, or any loss sustained by the undersigned or any of the undersigned's group while contracted with the Festival. It is agreed that the above contractor (herein referred to as Vendor or group) is an independent contractor and as such is responsible for any and all taxes, including workmen's compensation. For the purposes of this contract, all references to Four Winds or Festival refer specifically to the Four Winds Productions event.
